



## Cookies policy

### I. Definitions

- 1.** Administrator - ORION RAIL LOGISTICS Sp. z o.o. Sp. k. with its registered office in ul. Stanisława Wyspiańskiego 28, Nowy Sącz, ZIP code 33-300, NIP: 7343526248, entered in the National Court Register under KRS number 0000517463
- 2.** Cookies - computer data, small text files saved and stored on the devices through which the User accesses the Administrator's website [orionraillogistics.pl](http://orionraillogistics.pl)
- 3.** Device - an electronic device through which the User accesses the Administrator's website.
- 4.** User - means an entity to whom, in accordance with the Regulations and legal provisions, electronic services may be provided, or with whom an agreement for the provision of services by electronic means may be concluded.

### II. The use of cookies

- 1.** The Administrator uses cookies via the website.
- 2.** Information collected from cookies is used to optimize the website, for statistical and advertising purposes.
- 3.** Cookies record website user activity by recognising the device, so that the website is displayed in a way optimized to individual user preferences.
- 4.** The solutions used on the website are safe for the devices of Users using the Administrator's website. It is not possible for dangerous or Malware software to get to the Users' devices.
- 5.** The Administrator uses two types of cookies:
  - a)** Session cookies: these are files that are stored on the User's Device and remain there until the session of a given browser ends. The stored information is then permanently deleted from the Device's memory. The mechanism of session cookies does not allow collecting any personal data or any confidential information from the User's device.



**b)** Long-lasting cookies: these are stored on the User's device and remain there until they are deleted. Ending the session of a given browser or switching off the Device does not delete them from the device. The mechanism of persistent cookies does not allow collecting any personal data or any confidential information from the User's device.

### **III. Ways of defining the conditions for storing or accessing cookies**

**1.** The User has the possibility to restrict or disable the access of cookies to his device. If this option is used, the use of the Website will be possible, except for functions that by their nature require Cookies.

**2.** The User may, independently and at any time, change the settings concerning cookies, specifying the conditions for storing and accessing cookies to the User's device. The User may change the settings referred to above by means of the settings of their Internet browser or the configuration of the service. These settings may be changed in particular in such a way as to block the automatic handling of Cookies in the settings of the Internet browser or inform on their placement on the device each time. Detailed information about the possibility and methods of using cookies is available in the software (browser) settings.

**3.** The user can delete cookies at any time using the functions available in the web browser he or she is using.
